TERMS AND CONDITIONS

1. Jindee Bonus:

The Seller offers to provide one Jindee Bonus per lot subject to the Buyer satisfying and strictly complying with the Eligibility Criteria and Redemption Criteria.

2. Eligibility Criteria:

- 2.1 To be eligible for the Jindee Bonus a Buyer must:
 - (a) Enter into a contract for Sale of Land of an Eligible Lot in Jindee Estate before the 31st of May 2020.
 - (b) Complete settlement of the purchase of the Eligible Lot on time and in accordance with the terms and conditions of the Contract.
 - (c) Provide Seller a copy of the signed building contract.

- (c) The Jindee Bonus is inclusive of GST.
